On December 27, 2024,
ATF Tampa Field Division

Special Agent Matt Murray attempted to deescalate a violent encounter at a local bowling alley in Riverview, Florida. As Special Agent Murray was engaging one of the violent combatants, another member of the group approached Special Agent Murray and shot him in the back of the neck.

His wife and kids were present when this incident occurred.

Special Agent Murray was transported to Tampa General Hospital, underwent surgery overnight, and is currently in critical condition in the ICU. A bullet fragment injured his C6 vertebrae as well as other areas, and he has limited mobility in the upper extremities.

Special Agent Murray is conscious and alert, but it is anticipated that he will be paralyzed from the waist down with a prolonged recovery time.

Turning Tragedy into Action

As 2024 draws to a close,, the numbers paint a heartbreaking picture. Over 16,000 lives have been lost to gun related violence, with another 31,000 people injured.¹ And among those numbers are some of the most vulnerable—244 children aged 0-11 and 1,145 teenagers aged 12-17.

These aren't just statistics; they're stories of lives cut short, and families forever changed. Take this past Christmas morning, for example. While many of us were unwrapping gifts, tragedy unfolded in Milwaukee, Wisconsin. A 15-year-old lost his life to gunfire before 11:30 a.m., and the same incident claimed the life of an 18-year-old who succumbed to injuries later at the hospital. Not far away, a 6-year-old was rushed to the hospital after being seriously injured in another shooting.

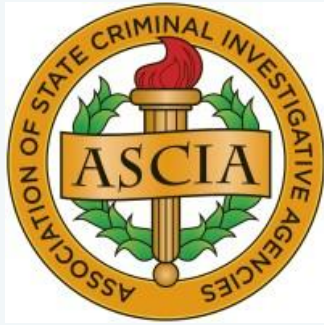
